Introduction

As a signatory to the Concordat to Support Research Integrity (Concordat), Bournemouth University (BU) is committed to fulfilling the principles of the Concordat and provides a framework for good research conduct and its governance.

In accordance with the Concordat, this annual statement outlines the activities in support of the highest standard of rigour and integrity in all aspects of research undertaken at BU during the 2018/19 academic year.

During 2018/19 the following activities continued to support research integrity:

- Regular training workshops for research students continued to be delivered under the Doctoral College's Research Development Framework Programme.
- Bespoke training workshops for supervisors were delivered under Supervisory Training by the Doctoral College.
- Regular training workshops for Researchers (staff and postgraduate research students) was delivered under the Research and Knowledge Exchange Development Framework by Research Development & Support (RDS).
- Updated Online ethics e-modules continue to be mandatory for all those carrying out research under the auspices of BU.
- University Ethics Committee (UREC) continued to provide oversight of activities and assurance on behalf of Senate.
- Science, Technology & Health and Social Sciences & Humanities Research Ethics Panels (REP), on behalf of UREC, continued to ensure best ethical practice by

reviewing, rejecting or approving research ethics applications for Staff and PGR (high risk).

- Faculties and Departments continue to manage the review and approval process of ethics submissions for UG, PGT and PGR (low risk), with oversight by UREC.
 - Supervisors continue to review the PGR ethics checklist to ensure a good quality. Low risk ethics checklists are approved by an appropriate Ethics Champion and REPs continue to review and approve high risk PGR checklists.
 - UG and PGT checklists continue to be reviewed and approved by Supervisors (low risk projects) and Ethics Programme Team (high risk projects).
 - A wide range of education and training provision is provided by Departments across the University where research is an integral part of the Undergraduate or Master's programme of study. Research integrity is discussed as part of research methodology units or bespoke online ethics modules. Each Faculty is supported in the research ethics process by the Deputy Dean for Education & Professional Practice and Deputy Dean for Research & Professional Practice.
- The research website has been updated to include a section on Concordats which support research which will improve visibility and external access to the annual statements. (Formerly available via the research ethics blog).

Ongoing activities

- During 18/19 the online ethics checklist was reviewed (taking into account comments received from faculties) and has been updated to include improved workflow process and clearer questions in sections relating to working with human participants. The new checklist will re-launched September 2019.

The Research Misconduct policy applies to staff and postgraduate research students undertaking research under the auspices of the University. It also applies to undergraduate and postgraduate taught students in relation to suspected cases of a serious breach of research ethics.

In 2018/2019 there were no reported cases of allegations relating to research misconduct made against any UG, PGT or PGR student.
